#### Garden State Parkway North

- Garden State Parkway North to Exit 161
- Turn Right onto Route 4 East (approx 1.25 miles)
- Turn Right into driveway for The Atrium, Hanjin Shipping Building
- Forman Holt Eliades & Ravin is on the 2nd floor, Suite 290

#### Garden State Parkway South

- Garden State Parkway South to exit 163 (LEFT-HAND exit ramp)
- You will be on Route 17 South (approx 1 mile)
- Take ramp to Route 4 East (approx .5 miles)
- Turn Right into driveway for The Atrium, Hanjin Shipping Building
- Forman Holt Eliades & Ravin is on the 2nd floor, Suite 290

#### Route 17 North

- Take Route 17 North to Route 4 East
- Turn right onto Route 4 East (approx .5 miles)
- Turn Right into driveway for The Atrium, Hanjin Shipping Building
- Forman Holt Eliades & Ravin is on the 2nd floor, Suite 290

#### Route 17 South

- Take Route 17 South to Route 4 East
- Bear Left onto Route 4 East (approx .5 miles)
- Turn Right into driveway for The Atrium, Hanjin Shipping Building
- Forman Holt Eliades & Ravin is on the 2nd floor, Suite 290

#### Route 80 East

- Take Route 80 East to exit 62-A (Garden State Parkway North)
- Garden State Parkway North to Exit 161
- Turn Right onto Route 4 East (approx 1.25 miles)
